Abstrakt:	English: At the beginning of this century, two conflicting camps developed in Protestantism - Fundamentalists and Modernists. At stake in the debate which ensued between them were the historic doctrines of Protestant Christianity. Primary to the conflict was the view of scripture each side espoused. Bob Jones College, founded by the Southern Evangelist Bob Jones, took as its mission the education of youth in the 'essentials of culture' and the

arts and sciences, giving special emphasis to the historic tenets of Protestantism. Bob Jones, Sr., made the connection between societal culture and Christianity and provided a campus environment in which artistic endeavor was acceptable and social grace was expected. Based on his Fundamentalist theology, Bob Jones, Jr., applied these ideals of the arts and social refinement and developed on the campus a program of selective artistic experiences for the benefit of the students. The Joneses termed this the 'cultural program' of the school.

Popis: This article interprets the rise of Protestant fundamentalism through the lens of an influential network of business leaders and theologians based in Philadelphia in the 1910s. This group of business and religious leaders, through institutions such as the Philadelphia School of the Bible and a periodical called *Serving and Waiting*, popularized the apocalyptic theology of premillennial dispensationalism. As the world careened toward war, Philadelphia's premillennial dispensationalist movement grew more influential, reached a global audience, and cemented the theology's place within American Christianity. However, when the war ended without the anticipated Rapture of believers, the money, politics, and organization behind Philadelphia's dispensationalist movement collapsed, creating a vacuum that was filled by a new movement, fundamentalism. This article reveals the human politics behind the fall of dispensationalism, explores the movement's rebranding as fundamentalism, and highlights Philadelphia's central role in the rise of Protestant fundamentalism.

Their 'revisionism' eventually won out in the 1960s, in the second stage, when Czech sociology of religion achieved international acceptance and Kadlecová became (for a short time) the author of the state's new religious policy. Although these scholars (V. Gardavský and M. Machovec) accepted a wider definition of religiosity and debated with Christian scholars, they remained Marxists. They were convinced religion is doomed to extinction. The last stage began after the violent termination of the Prague Spring in 1968 and lasted throughout the era of the so-called normalisation in the 1970-80s. Progressive scholars were removed from their posts. The official sociology of religion changed its name to 'scientific atheism', but the outcomes of its work were far from any standard of excellence, both in the theoretical and empirical fields. Research from the era of official neo-Stalinism was very poor in quality, but during that time very important unofficial scientific contributions did emerge, written by banned sociologists (E. Kadlecová, J. Šiklová), social theologians (B. Komárková), and Czechs in exile. Unfortunately, since 1989 the reception of these works has been narrow. Popis: The fiftieth anniversary of Sociologický časopis (since 2001 Sociologický časopis / Czech Sociological Review) provides an ideal opportunity to discuss the presence and achievements of the sociology of religion in the most important Czech sociological journal and to contribute to the historical, theoretical, and methodological analysis of Czech sociology of religion itself. The author provides a summary of all the articles, reviews, and information on the topic published in the journal and shows that, regardless of its importance within Czech sociological discourse at the various stages in the development of the discipline, the sociology of religion has generally had only a limited presence in the journal over the years, for both internal (sociologists of religion were not considered 'core members' of the sociological community) and external reasons (fear of what was considered a 'problematic' topic during the communist era and the non-existence of 'untarnished' students of religion after the collapse of the communist regime). The situation changed only recently, broadly speaking in the last decade, as younger generations seized the initiative and research on religion became a standard part of the Czech sociological mainstream. However, only a small number of contemporary sociologists of religion publish articles in the journal and, consequently, this sub-discipline is still far from being a consistent presence in its pages. The limited degree to which Czech sociology of religion has established itself in the pages of Sociologický časopis / Czech Sociological Review thus raises fundamental questions about the nature of the discipline, its students, and the broader sociological environment.
