Short summary

The presented thesis analyses the political budget cycle of Czech municipalities. The author uses a fixed effects model to describe the influence of municipal election on expenditures in the last three election terms. It also offers a more detailed look into the structure of municipal expenditures for all three types of municipalities.

Contribution

This thesis adds to the existing literature on the topic of political cycles by adding the information about mayors' political affiliations as well as distinguishing between each type of municipality. In the case of type I municipalities, of which there is the vast majority, this analysis is the first in the academic literature as far as I'm aware. We must not forget about the data collection, which in the case of political affiliations is more difficult than expected, as no comprehensive information about mayors are publicly available, not even provided by the Ministry of Interior. Adriana had to create her own dataset, inspired by Navrátilová (2021).

Methods

The empirical part of the thesis is based on a regression of current and capital expenditures for the three types of municipalities. After a discussion of panel data estimation methods as well as standard tests for autocorrelation and heteroskedasticity, the author chose fixed effects with HAC standard errors. Although the author follows a simple procedure, she validates her choices by discussing theory and correctly interpreting her results. In the next step, she alters the specification of her model to closely examine the effect of the election cycle. She found out that in all types of municipalities, capital expenditures increase in the areas of transport, culture, sport and leisure before elections.

Literature

The thesis shows an adequate command of the related literature, which is discussed clearly in the literature review (*Chapter 2*) as well as appropriately cited throughout the text. The results of the Urkund analysis do not indicate significant text similarity with other available sources.

Manuscript form

The work reads very well without any disruptions and struggle of the intended meaning. It is written in nice English, follows a standard structure and is well organized. Tables and figures are also formatted well and labeled properly.
