The study focuses on applying the Gompertz-Makeham mortality law in actuarial calculations for life insurance. This method simplifies actuarial calculations by relying on the gamma function, which requires only a few parameters. The study explains and applies specific estimation methods to evaluate life annuities within the Czech population.
